Conditions for participation

Participation in the Berlin Valley competition, hereinafter referred to as the operator or organizer, is free of charge and is subject exclusively to these conditions of participation.

Contest procedure

The duration of the competition is limited from 04.07.2019 - 12.07.2019, 11:00 am. Users can take part in the competition within this period.

Commiserations

In order to take part in the competition, the user must fill in a type form and leave his contact details. Participation is only possible within the participation period. Entries received after the entry deadline will not be considered for the draw.

Only one competition entry per participant is possible. It is strictly forbidden to use multiple accounts to increase the chances of winning. Participation in the competition is free of charge. By participating, the participant accepts the general terms and conditions and data protection regulations.

Eligible participants

Eligible to participate are natural persons who have their residence in Germany and have reached the age of 14. Participation is not dependent on the purchase of goods or services. If a participant's legal capacity is restricted, the consent of his legal representative is required.

All persons and employees of the operator involved in the conception and implementation of the competition are not entitled to participate in the competition. In addition, the operator reserves the right to exclude persons from participation at its own discretion if there are justified reasons, for example:

- (a) in the event of manipulation in connection with access to or execution of the competition,
- (b) in the event of violation of these Terms and Conditions,
- (c) in the event of unfair conduct or (d) in the event of false or misleading information in connection with participation in the competition.

Winning, Notification and Transmission of the Prize

The winner is responsible for any taxation of the prize. If the winner does not respond after two requests within a period of 2 days, the prize can be transferred to another participant.

The organizer expressly reserves the right to end the competition without prior notice and without giving reasons. This applies in particular to any reasons that would disrupt or prevent the scheduled course of the competition.

Data privacy

Personal data is required to participate in the competition. The participant assures that the personal information provided by him is true and correct. The organizer points out that all personal data of the participant will neither be passed on to third parties nor made available to them for use without their consent. In the event of a prize, the winner agrees to the publication of his name and place of residence in the advertising media used by the organizer. This includes the announcement of the winner on the website of the operator and its social media platforms. The participant can revoke his declared consent at any time. In this case, the revocation must be addressed in writing to the contact details of the organizer given in the imprint area. After revocation of the consent, the collected and stored personal data of the participant will be deleted immediately.
